**STANDARD PRICING SCHEDULE GS-DG  
GENERAL SERVICE WITH DISTRIBUTED GENERATION**

**AVAILABILITY**

Available for commercial customers requiring either single-phase or three-phase service with a peak demand in any month of less than 50 kW. Service will be supplied through one meter at one standard secondary voltage. No resale, breakdown, auxiliary, or supplementary service permitted. Where commercial and residential services are served through one meter, the General Service Rate shall apply to the entire load.

The Customer's distributed generating installation shall not exceed 50 kW. This requirement may be reviewed on a case by case basis by the Director of Edmond Electric or his/her designee.

The Customer must be in good standing with Edmond Utilities, who owns and receives electric service at the Premise where the permitted and conforming distributed generation system is installed and operated and have a current "Agreement for the Interconnection of a Customer Owned Distributed Generation System" with the City of Edmond.

Under the terms of Edmond Electric's wholesale power supply contract, Edmond can allow a maximum cumulative distributed generation capacity of one percent (1%) of the Edmond's single hour peak load to be installed on its electric distribution system. This capacity is allocated on a first-come, first-served basis. If the cumulative generating capacity of solar systems reaches the maximum 1% of Edmond's single hour peak load, Edmond Electric cannot not allow any new systems to be interconnected to our distribution system.

### STANDARD PRICING SCHEDULE GS-DG GENERAL SERVICE WITH DISTRIBUTED GENERATION

#### ENERGY CHARGE

The Energy Charge will be applied to all kWh supplied to the Customer by Edmond Electric over the billing period as measured by the Edmond Electric revenue meter.

**Summer Season** (*Revenue Months of June – October*)

All kWh per month                      \$0.1055 per metered kWh

**Winter Season** (*Revenue Months of November – May*)

First 1000 kWh per month              \$0.0908 per metered kWh

All additional kWh per month \$0.0505 per metered kWh

#### MINIMUM CHARGE

The minimum monthly charge shall be the Customer Charge plus applicable rate riders.

#### FUEL COST ADJUSTMENT

See Standard Pricing Schedule FCA, Rider for Fuel Cost Adjustment. The Fuel Cost Adjustment will be applied to all kWh supplied to the Customer by Edmond Electric over the billing period as measured by the Edmond Electric revenue meter.

#### CREDIT FOR EXCESS GENERATION

No credit will be given for excess generation supplied back to the Edmond Electric distribution system from the Customer's distributed generation system.

### STANDARD PRICING SCHEDULE GS-DG GENERAL SERVICE WITH DISTRIBUTED GENERATION

#### AVERAGE MONTHLY BILLING

Service provided under this rate schedule does not qualify for the Average Monthly Billing Program.

#### TERM

Participation in this rate schedule shall continue until termination from the program per the terms and conditions set forth in the "Agreement for the Interconnection of a Customer Owned Distributed Generation System" entered into between the Customer and Edmond Electric. This rate and all associated terms and conditions for service shall be governed by and subject to policies and procedures of the City which may be amended, revised, modified or repealed at any time by the City, in its sole discretion, without notice to the Customer.

Edmond Electric may require a written contract for a year or longer, containing minimum guarantees warranted by special circumstances or unusually large investments by Edmond Electric.
